ISC2 offers a variety of awards that recognize individuals who have made outstanding contributions to cybersecurity and who have made a difference in this ever-evolving industry by honoring their tireless efforts and standards of excellence. With our Global Achievement Awards program, ISC2 recognizes individuals whose excellence in leadership and volunteer efforts have significantly advanced the cybersecurity industry and contributed to our vision of inspiring a safe and secure cyber world.

Committee Charge

The ISC2 Global Achievement Awards (GAA) committee is charged with selecting the award recipients for a specific region. Committee members will abide by Conflict of Interest Policy for ISC2 Awards

Program, Non-Disclosure Agreement and Volunteer Agreement, including program policies, procedures and guidelines set by ISC2. In partnership with staff, the committee works to ensure that the program is superior in all respects, recognizes all constituents, and fosters a global network of individuals in the cybersecurity and information technology industry who epitomize excellence in their work. The members of the Awards Committee will promote excellence and transparency, allowing broad input and recognition beyond the awards, promoting diversity and equity so that the awards are sufficiently representative of underrepresented groups.

Key Duties

The Committee's work is completed primarily through the online submission and review system, teleconference and email to support the following initiatives and duties:

- Review data from past selection processes to determine if the program is aligned with ISC2 goals
- Examine and report on program data to determine whether the number and quality of nominations are competitive
- Select the award recipients in a specific region
- Recommend, implement, and evaluate strategies used to increase diversity of nominations
- Participate in training, orientations and workshops on associated policies and procedures
- Understand and commit to Conflict of Interest for ISC2 Awards Program, Non-Disclosure Agreement and Volunteer Agreement policies and processes
- Provide input and recommendations to staff and ISC2 leaders on program improvements
- Partner with ISC2 leaders and staff to resolve common issues among communities' rewards and recognition programs

Committee Chair: Appointed by ISC2 EVP

Term Length: March 2024 – December 2024

Attendance: All committee members are expected to attend a minimum of 75% of

committee meetings and participate in the programs and activities of

the committee as outlined by this charter.

Renumeration: Committee members will not receive any compensation or

renumeration for their participation in this group. Task Force members

holding ISC2 certifications will receive appropriate continuing

professional education credit for their activities.
